PERFORMANCE REPORT: 2017-18

ACES HIGH SCHOOL

CES High School was established in 1985 to provide an academic option for high school students in the Mukilteo School District. It is a school of choice, although students also are often recommended by staff at the school district's other two high schools, Mariner and Kamiak. A creative, educated, and experienced staff works to provide a personalized educational environment with a focus on individualized instruction, high levels of learning achievement, and personal development. The school maintains a consistent enrollment in the range of 175 to 185 students in grades 10 through 12. ACES teachers build positive relationships with students while providing quality instruction and creating a classroom environment that promotes student achievement. Courses are available across all content areas plus a variety of electives in the areas of family and consumer science, business and technology, industrial technology, art, and yearbook. Plato, an online curriculum, is available for students needing an additional credit recovery opportunity. ACES High School completed the accreditation process in June 2014 and has been granted accredited status through 2020.

ABOUT OUR SCHOOL

ACES is located in a natural setting that is surrounded by a wetland. The facilities include an athletic field. An extensive remodel in 1997 created a campus that incorporates remodeled portables, a new gym and weight room, a technology center and library, construction trades facility, and administrative offices. Technology is used in each classroom to enhance learning opportunities. The majority of classrooms are equipped with a document camera and classrooms utilize interactive whiteboards (Activboards) to enhance instruction



and learning achievement. ACES now houses five Chromebook carts utilized in classrooms throughout every day. Our goal is for every classroom to integrate the most current technology into daily instruction in combination with other differentiated instructional options.

AT HOME

Research consistently shows that parent/family involvement is a necessary component of student school success. We encourage parents/families to be equal partners with ACES staff in the responsibility for educating their children. Parents/ families can support their child's high school goals by ensuring consistent attendance, assisting with academic work, and informing school staff of pertinent information. ACES staff members continue to make a conscious effort to communicate with parents/families regarding student progress. OUR IMPROVEMENT PLAN

ACES High School is continually moving forward with a focus on creating and sustaining an environment that promotes high levels of learning and academic achievement. Fifty-two students graduated from ACES in 2018, having met all state-mandated requirements. The ACES High School graduate will possess competencies in literacy, math, science, social studies, health and physical well-being, the arts, and career and technical education. A graduate will demonstrate evidence of self-directed behavior and has goals for the future. Students spend considerable time researching and creating their post-high-school plan. They meet with our career counselor, who assists them in their plans, and often participate in presentations and field trips to college campuses.

ACES students are exposed to responsible use of technology, making successful choices, and setting and achieving both long- and short-term goals. ACES provides a multitude of academic experiences that allow students to develop intellectually. ACES offers both AP Government and Art 3, an advanced art class for our highly artistic students. Cooperative work and other social development opportunities encourage effective communication, healthy relationships, and work and school success.

ACES teachers are experienced, talented, and adept at meeting the individual needs of our highly diverse student population. Staff development focuses on a positive approach to behavior management as well as the current trends with instructional strategies and assessment practices. A school-wide intervention system has been implemented for the purpose of tracking student progress and providing early intervention. High levels of collaboration among teachers exist in both the English and math departments and among the entire staff with regards to student achievement and social/emotional development. Students receive an endless supply of support from the adults on staff for the purpose of academic success and personal growth.

ACES proudly enrolls an exceptional and diverse population of students who are intelligent, creative, artistic, multi-talented, and motivated to achieve their high school diploma. Our goal is to reach every student every day in the ongoing effort to support their goals of high school success.

STANDARDIZED TEST RESULTS

WASHINGTON STATE STANDARDIZED ASSESSMENTS:

10TH GRADE

High school students in the state of Washington are given a number of different tests to determine their achievement level. Smarter Balanced Assessments (SBA), which measure student achievement toward the Common Core State Standards in English/language arts and mathematics, were first given in 2015. Students in grade 10 took the English/language arts test. The scores below indicate the percentage of students who met the state standard in that assessments in the 10th grade. The Smarter Balanced Assessment (SBA) in math is given to 10th grade students.

PARENT SURVEY


An education reform bill passed by the Washington State Legislature requires that schools seek feedback from parents and summarize the response in their annual Performance Reports. The Mukilteo School District has conducted a survey of parents in each of the past 20 years.

The survey conducted in the spring of 2018 had a total of 2,715 respondents, which represents a return rate of about 20 percent. The survey found that about 77 percent of parents feel welcome at their child's school and 72 percent feel staff members are responsive to their requests for information or assistance. District-wide, about 74 percent of parents have a positive impression about the quality of education at their child's school.

The survey also found that parents generally feel well informed about what is going on in their child's school and that parents feel school buildings and grounds appear clean and well maintained. The vast majority of parents report that their child feels safe at school and that staff members respect and appreciate diversity.

At ACES, about 78 percent of parents said they feel welcome at school and 67 percent said they have a positive impression about the quality of education at the school. Another 22 percent were either neutral on the subject or had no opinion.

STUDENT ACHIEVEMENT FUNDS: Washington voters approved an Initiative in 2000 to dedicate funding that would help assure that students meet the learning requirements set forth in the state's education reform program. The Initiative encouraged school districts to work in partnership with their communities to determine how those resources could be used most effectively.

The amount of Student Achievement Funds made available to schools was greatly reduced beginning in 2009 and finally suspended entirely for the 2010-11 school year. The state legislature also suspended all Student Achievement Funds in all budgets that have followed.
